- 一、 畢業至少應修滿 73 學分【必修 34 學分,選修至少 39 學分(其中至少需含本系專業選修 26 學分)】。 Students should complete at least 73 credits before graduation, including 34 required credits, 39 elective credits (elective credits should have at least 26 credits from department elective courses).
- 二、 選修通識課程包含性別平等、智慧財產權、海洋教育等相關課程;選修通識課程由通識學院協助開設。 Liberal Education Courses include gender equality courses、intellectual property courses、marine education courses, and these courses provided by College of General Education.
- 三、 課程名稱前有標示「△」符號者,為「程式設計課程」。 Courses with a "△" refers to an application design course.
- 四、 課程名稱前有標示「●」符號者,為「職能專業課程」。 Courses with a "●" refer to a professional competence course.
- 五、 課程名稱前有標示「AI」符號者,為「人工智慧相關課程」。 Courses with an "AI" refer to an artificial intelligence related course.
- 六、 一下選修課程:應於「財務管理」、「策略管理」、「資料庫導論」、「生產與作業管理」、「人力資源管理」及「資訊管理實務」六 門課程中必選修三門。 Elective courses in the second semester of the first year: Three out of the six courses of "Financial Management", "Strategy Management", "Introduction to Database", "Production and Operation Management", "Human Resource Management" and "Information Management Practice" are compulsory.
- セ、 二上選修課程:應於「商用英文」、「組織行為」、「人工智慧」、「消費者行為」、「知識管理」、「財務會計資訊系統」、「進銷 存管理資訊系統」及「資訊安全」へ門課程中必選修四門。 Elective courses in the first semester of the second year: Four out of the eight courses of "Commercial English", " Organizational Behavior", "Artificial Intelligence", "Consumer Behavior", "Knowledge Management", "Financial Accounting Information System", "Invoicing Information System" and "Information Security" are compulsory.
- 八、 二下選修課程:應於「市場調查與分析」、「會計資訊系統實務」、「進銷存資訊系統實務」、「物料管理實務」、「電子商務實務」、「休閒管理」及「通識課程」七門課程中必選修四門。
  Elective courses in the second semester of the second year: Four out of the seven courses of "Marketing Research Methods and Analysis", "Accounting Information System Practice", "Invoicing Information System Practice", "Material Management Practice", "Electronic Commerce Practice", "Leisure Management and Liberal Education are compulsory.
